You recently received my autumn fundraising letter in which I discussed the centennial anniversary of our beloved Hillcrest. I spoke in that letter about the extraordinary efforts of alumni brothers Ralph S. Kent '02, Edward A. Wadsworth '04, and William H. Marland '01 in making the construction of the new Hillcrest happen after the original Hillcrest was totally destroyed by fire on June 10, 1911. I often think now about what an amazing task it was for a group of alumni to plan, get funding for, and manage the construction of a new fraternity house-and to balance that against conducting their daily lives. In just four years, they had Hillcrest up and occupied. Think of the commitment that it took on their parts in an age without electronic communications to start and see that project through to fruition in just four years' time. Their goal was to construct a new fireproof structure that would stand the test of time for our fraternity. They succeeded. Will we?

We now sit at a similar crossroads in NY Alpha's history, and I would assert that our task is more daunting than what our forefathers faced over 100 years ago. Our Strategic

Plan, which can be viewed on our website at sae-cornell.org, requires that we not only recruit and build an active organization from scratch, but also implement new policies unfolding at SAE national and the university.

For example, our national fraternity, under the leadership and direction of the Supreme Council, made a historic decision earlier this year that will realign the fraternity to produce the original member experience that our founding fathers envisioned. Effective March 9, 2014, new-member (pledge) programming was eliminated completely from all our operations, and the classification of new member (pledge) no longer exists. At the same time, the new True Gentleman Experience was established to enhance the educational and leadership experience of all our members and build on their development during each year of their collegiate tenure. Under the new program, chapters and colonies may continue to recruit prospective members as they do currently, but when a bid is extended, the college man who accepts the invitation will become a collegiate member instantly upon acceptance. "From the moment a man joins Sigma Alpha Epsilon, he

Here is an update about Richard L. Peterson '57 that was culled from the June 2014 Harvard Business School (HBS) Alumni Bulletin. "Last year was hell," Dick wrote. It all happened during the first six months, climaxing just before the 2013 50th HBS Reunion, which he had planned to attend. He lost his only son and only brother within one week in May. The toughest was the loss of his son, Todd, who was born in Boston in December 1961, causing Richard to get a U on his WAC that week. ("A U on his WAC" is HBS language for an unsatisfactory grade on his Written Analysis of a Case, a paper that had to be submitted every other week by 5:00 p.m. on Saturday-which kept first-year students up all Friday night.) Foremost Benefactors

"Foremost Benefactors" is the honorary title bestowed upon those who have given freely of their resources to advance and shape Cornell University for the benefit of future generations. This recognition represents one of the highest honors conferred upon Cornell's philanthropic leaders. Recipients are given a 12-inch cast bronze replica of the Ezra Cornell statue on the Quad, and their names are engraved on the terrace wall at the south side of the Libe Tower, a place of permanence far above Cayuga's waters.

The designation originally recognized lifetime giving of \$500,000, Ezra's original endowment gift. It has increased over the years and is now at \$3 million.

The seven NY Alpha SAE Foremost Benefactors, from the classes of 1915, '42, '49, '56 (3), and '59, are listed below. Five have passed away.



Walter Raymond Read
'15: Walter Raymond "Ray"
Read was a mechanical engineer (ME) from Milwaukee. He
was a captain in the U.S. Army
Quartermaster Corps during
World War I. When his dad died

suddenly of a heart attack in 1922, Ray, age 29, took over the business he ran, Filer and Stowell. The company, which manufactured heavy equipment for sawmills, was founded in 1855. His dad joined it as an office boy in 1878 and worked his way up to the presidency. Ray also managed several other businesses owned by the Read family.

Ray and his two younger brothers, Everett '17 and Stuart '18, were all Cornell SAEs and MEs. His two nephews were also MEs but are Alpha Delts. In researching Ray, Ron Demer spoke with one nephew, Charlie (88), who was aware of Ray's support for Cornell. Ron told Charlie about the Brownings, another multi-generational ME Cornell family with an SAE Foremost Benefactor. An interesting connection between Filer and Stowell and Browning Manufacturing, which made power transmission systems, emerged: Filer and Stowell "had Browning V-belt drives throughout its factories." Ray died in 1979.

George Bedell Howell '42: George was SAE president and a member of Sphinx Head. He held senior management positions at Royal Electric, VLN Corporation, GE, and International Minerals and Chemicals



before he became CEO of Wurlitzer Corporation in 1980 and chairman in 1982. The company is best known for theater organs that accompanied silent movies and jukeboxes. He died in 2008.



Robert T. Dean '49: After growing up in Indiana and attending IU for a year, Bob served as a U.S. Army Air Force bombardier before enrolling in Cornell's

electrical engineering program. He was a versatile football star in the backfield and with his kicking toe, setting records for kicking and the longest play from scrimmage. Bob was the *Sun's* athlete of the year in 1949 and is in the Cornell

Athletic Hall of Fame. After graduating, he started Bob Dean, Inc., and Deanco, an electronic manufacturer's rep and distributor, headquartered in Ithaca with offices in six states.

Bob saved Hillcrest in the early 1980s when the house was not viable financially and about to fail. He developed a plan that would ensure the continued existence of SAE at Cornell, a three-way relationship between the active brother-hood, the alumni association, and Cornell that set the framework for a partnership that has endured to this day.

He passed away on Homecoming day in 2010. More than 100 people attended an Ithaca service celebrating his life.

Curtis Sanford Reis '56: Global traveler to seven continents, lifelong sports enthusiast, and a man committed to social justice, Curt Reis passed away in early 2014 from complications of heart failure.



As an undergraduate, he was eminent archon at SAE, a leader on campus, chair of the Willard Straight board, and a member of Quill & Dagger.

Curtis considered Cornell a defining element in his life. One of a long line of Cornellians (who include both of his parents, his sister, brotherin-law, daughter, niece, and grandson), he was president of the class of '56, co-founder of Cornell's Adult University, a trustee, and recipient of the Frank H. T. Rhodes Exemplary Alumni Service Award. He and his family have given generously to Cornell; the Reis Tennis Center is their most notable gift.

A lifelong banker, Curtis worked for The Bankers Trust Company and Crocker Bank, and he was chairman and CEO of Alliance Bank.



David S. Hugle '56: A hotel grad, Dave worked for Marshall Field & Company and a national accounting firm that specialized in the hospitality field until 1972, when he and

fellow SAE Todd Jenkins '59 opened a restaurant called Salmagundi in the financial district of San Francisco. An instant hit with its limited menu of soups, salads, and desserts, Salmagundi grew to six locations by 1985, when they sold the successful group.

Dave's lifetime interest in music and art led him to join the board of the Merola Opera Program, a non-profit training program for young opera artists closely associated with the San Francisco Opera. He served as an officer and board member there for 29 years. He also is on the boards of Chanticleer, the Grammy Awardwinning men's a cappella singing group, and the Marin Arts Council. He collects late 20th-century art, much of which is promised to the Johnson Museum at Cornell.



Robert Evans Browning '56: Bob Browning was a strong supporter of both SAE and Cornell. He endowed the director of physical education position in the athletic department with a gift of \$1 million. Bob was the youngest of three Browning brothers who attended Phillips Exeter Academy and were Cornell SAEs in the '50s. He won varsity letters in swimming and lacrosse.

The Browning family's Maysville, Kentucky, power transmission business, Browning Manufacturing, was sold to Emerson Electric (NYSE) in the late 1960s. Bob remained with Emerson, running two divisions until his retirement. He had two sons and two grandchildren who attended Cornell. He died in 2010.



Ron Demer '59: SAE Hillcrest was at the core of Ron's Cornell experience, bringing him a beautiful building and brotherhood with the outstanding men who have been his best friends since his years on the hill.

Ron was active on campus as an IFC officer and member of Quill & Dagger. As an alumnus, he has served as '59 class president and 50th Reunion chair, SAE chapter adviser, Cornell Club president in Boston and Atlanta, and Quill & Dagger alumni president.

His business career was in computers, advertising, equipment financing, and cable television. In 2001, Ron moved back to Ithaca, where he enjoys campus and Ithaca activities—and hosts many SAEs. His gifts to Cornell support athletics and scholarships.

New Wing Roof Replacement Underway

In September Cornell awarded a contract to a local roofing contractor to replace the new wing roof. After mobilizing in early October, the contractor removed the old roof within a day and was expected to have the new roof installed quickly. The new roofing system is an upgrade from the last and consists of rigid R30 insulation panels and a fully adhered two-ply waterproof membrane. The new roof is one of the most durable types available and is designed to withstand debris from adjacent trees, foot traffic, and weather. The roof comes with a 20-year warranty.

Anyone who lived in the new wing knows that the old roof was a source of continual leaks. The roof had been patched and repaired many times over the years. The most recent repair was in 2012, when an infestation of rodents was discovered within the roof insulation.

Looking ahead to next summer, we are planning a house-wide window replacement project. The project will replace the current windows with new, energy-efficient thermal-pane windows. The new windows are expected to reduce annual heating costs significantly.
