Kevin T. Merriman '88: 2017 True Gentleman of NY Alpha



Most of you probably read the last NY Alpha News front-page column written by Kevin Merriman '88 about his tenure as president of the New York Alpha Alumni Association and board member for the

last 15 years. He describes what he remembers most and best about the experience as being merely and all about fellowship!

When we increased the size of the board years ago, Kevin was one of the first to volunteer to serve. We were at a point where it was important for the board to do more to serve the chapter and Cornell than was possible with just the small handful of alumni involved who had run things for years. It was a time for transition.

Out of this effort emerged a full "working board" of around 20 alumni. In the beginning, as treasurer, Kevin did a good job keeping our finances in order. After a very few years, we asked Kevin to become president. Although reluctant at first, he agreed.

Not surprisingly, for the next several years, committee activities and accomplishments all increased. More money was raised because we had a strong fundraising team headed by Mike Slusar '86. More facilities work was done because we had a strong team headed by Jim Beckett '85. And the programs/outreach committee took on more programming because that team was strong and motivated as well.

But the fact is that all three teams and the cadre of board officers were under the steadfast leadership of Kevin as president. Without his guidance and management skills, so much of what we accomplished would not have been possible.

Because of Kevin's commitment to results, Hillcrest has evolved into a facility that has the potential to be competitive with the best the Cornell fraternity system has to offer. In addition, the strength and quality of the board has never been better. Those were his goals: goals we in turn made our goals-and that is where we are today. That is the true substance of Kevin Merriman's rich legacy.

Noteworthy was that Kevin led the organization during times of significant change and significant difficulty. Kevin's professional and focused leadership made all the difference as we greeted growth and change and met challenges.

Inspired by this and as a testament to the fellowship he relished, most members of the NY Alpha board continued their board service well beyond what they might have originally envisioned. This proved essential to our organizational strength and endurance in recent years.

As Kevin concluded in his article, it has been guite a run! And we all should thank him for that.

After six months as president of your NY Alpha Alumni Association, I am hardly a veteran. However, I have learned a few things in that short time—or perhaps I've been reminded of some things I already knew. What-

ever the case, I offer them for your consideration.

The recent celebration of our fraternity's 161st birthday on March 9 (Founder's Day) reminds me that we are part of a long-lived institution. I find it amazing that the ideals and vision of a group of college students—not unlike us at that age—can be carried forward for over a century and a half. How many institutions can you think of that have not only survived, but prospered, for that long? Recall that Cornell just celebrated its sesquicentennial. Our NY Alpha Chapter was in existence for 120 years. Certainly, there were some ups and downs during that period, but my reading of the history of our chapter is that the high points far exceeded the low ones.

These extended periods of excellence, I believe, account for another important observation: our alumni group is very strong. While I admit to limited knowledge of other fraternity alumni groups at Cornell, I can easily imagine ours is among the strongest. A significant number of you pay annual dues (of course, we would always like more). This allows us to stay connected via this publication and various onand off-campus events. Furthermore, we have consistently met fundraising goals for the Hillcrest SAE Development Fund. This, combined with efficient operation of the property, has enabled us to invest \$1.3 million in the house since our charter was suspended. If you haven't been to Hillcrest in the last few years, you should plan a visit (the June reunion would be an excellent time). I guarantee you will be impressed and amazed. It is gratifying that our alumni can provide this level of support while the undergraduate chapter has been inactive for over six years. It would have been easy to write it off, but you have not chosen that path. Because of this, I believe there is a very bright future for NY Alpha. Thank you, thank you, thank you!


My brief tenure on the board has convinced me that this level of alumni support has been possible because of the dedication and hard work of our board. The "heavy lifting" is done in our committees: facilities, fundraising, com-

munications, outreach. Their hard work keeps us in touch, raises the money, and figures out how best to invest in our home at Hillcrest. There are some stalwarts who can keep this up for a while longer, but the average age of our board suggests it is not sustainable for the long run. We need to broaden the age distribution of the board by adding members from the classes of, say, the last 15-20 years. As some of you know, our big project for 2017 is the replacement of the deck on the second floor. It has been said that the view from there is unmatched anywhere on campus. Those of you who have attended the last few reunions certainly enjoyed socializing out on the deck but also must have noted its deteriorating condition. So come back in June to see the new one!

A second project was just completed: the upgrade of the fire alarm system at a cost of nearly \$43,000. The new system replaces an old one that did not meet current safety standards.

While we have many projects on the drawing board, next in line will be several upgrades to the kitchen, as well as renovation of the chapter room and three rooms that surround it. We have a team of alumni working on plans for this area; this is described in more detail below.

We have estimated the cost of the kitchen upgrades at around \$50K. This includes new lighting, replacement of tables, and other built-in elements of the dishwashing room. Most of the kitchen equipment is serviceable

and works just fine. The walk-in needs some upgrades but is otherwise acceptable. Included in the cost is purchase of a pizza oven.

The team has been working hard on planning for what we're calling the rec room. Hillcrest needs a place where students can kick back and relax in a comfortable and informal setting. TVs would be ideal in the rec room as well, rather than on the fireplace in the living room (which detracts from the charm of that room). The Great Hall and living room are more "formal" and not suitable for these activities.

A tremendous outpouring of alumni support has gotten us to this point, and we are relying on that to continue as we move forward. There are many other projects on our list that need attention. Check out the ideas and supporting documentation at the facilities link on our website to learn more!

I am very pleased to report that our fundraising efforts continue to meet our ongoing goal to carry out our strategic plan for Hillcrest's repair and upgrades. Since 2011, we have replaced the Wing's roof, restored the library doors, reconfigured the rooms for additional single occupancy, replaced all of our "vintage" windows, and upgraded our fire alarm system. That represents a whopping \$1,300,000 investment into Hillcrest. Thanks to all of our loyal and true gentlemen, we continue to make a significant contribution to our favorite home away from home, Hillcrest. That is exceptional alumni commitment by any measure!

In following our long-term plan, we are now entering a phase that addresses many décor issues and items that generally affect the aesthetics of the house. By Reunion '17 we are going to have a new deck to enjoy. Furthermore, there are plans to make significant improvements to the chapter room and the rooms that immediately adjoin it.

The current plan for that space is to reconfigure the area as a "rec room." This would include creating a TV viewing area and installing entertaining games like indoor shuffleboard, darts, and of course a pool table. Some walls would be opened up somewhat between the three rooms to increase flow. We are also planning new and improved flooring as well as wall finishes and lighting for all areas.

While I'm excited about seeing this area develop, we have other goals further down the line to address improvements to the kitchen and dining room, as well as restoration of the general common areas and new and improved flooring in the bedrooms. These will all be things that we can see, touch, and enjoy! Now that's what I call "the good stuff"!


