### NY ALPHA APPLIES FOR RECOGNITION

SAE operated continuously on the Cornell campus for 120 years, and it has been nearly 10 years since the chapter was disbanded following the tragic death of George Desdunes '13. Now, I am pleased to report we have taken an important step forward: in September, SAE National and the NYA Alumni Association applied for recognition by the university.

That said, there are still several hurdles to clear in Cornell's expansion process before we can rejoin the Cornell community. Our application will be reviewed by a Growth Committee appointed by the Office of Sorority and Fraternity Life (OSFL) and comprised of about a dozen alumni, faculty, staff, and students. In addition to the written application, Grant Maris, Director of Expansion at SAE National, and I will meet with the committee (virtually, because of COVID-19) to answer any questions they have. The committee will then recommend whether to accept or reject the application. Normally, the committee would make its recommendation by the end of the fall semester; however, it may take longer because the committee is operating virtually. If approved by the committee, the Interfraternity Council will have to vote to accept the new chapter.

At that point, SAE National would be permitted to recruit and form an asso-

ciate chapter. We have worked closely with Grant and his team to prepare an application that we believe offers a compelling case to rejoin the Cornell community. SAE National will provide resources to recruit new members, form an associate chapter, and support chapter development. To obtain a national charter, a new chapter must complete certain tasks and meet a stringent set of requirements. This process typically takes 12 to 24 months. If we can meet this timeline, SAE could return to Hillcrest in the fall of 2023.

The application we submitted has three parts: a letter of intent, an expansion proposal, and an alumni support statement. The letter of intent lays out how SAE will partner with the university to become a contributing member of the university community. It describes how SAE will address issues of specific interest at Cornell (for example, diversity/ inclusion/equity, alcohol management, hazing prevention). Also included are lessons learned from George's tragedy and how we intend to incorporate those going forward. The expansion proposal describes the SAE philosophy, as well as its standards, processes, and programs. You can read all three elements of the application at SAE-Cornell.org in the member area under "Reinstatement Application" (log-in required).

As I wrote the alumni support statement, I was reminded how incredibly supportive and loyal you, the NY Alpha alumni, have been and how effective your Alumni Association board has been over



these 10 long years. The fact that we're still standing is a testament in itself! As an alumni association, our role with respect to the chapter collegiate is to support the chapter and its members with our time, talent, and treasure. To provide advice and counsel, we have developed a new chapter advising model (see Dave Martin's article on page 3). Thanks to your financial support, we have invested \$1.7 million to make Hillcrest a desirable living environment (see Hal Sieling's article on page 2). To demonstrate our ongoing support, we reached out to some of our loyal donors and asked for a five-year commitment to support a new chapter. We are extremely gratified that you stepped up with over a half million dollars of pledged support to the Hillcrest Development Fund. This is a strong statement that positions us solidly for success. I hope to have good news to report in the next issue of the New York Alpha News, if not before. With the support and resources of a strong national fraternity and an engaged and committed alumni base, I am increasingly confident we can realize the aspiration from our strategic plan: to develop a chapter that serves as a model for Greek life in the 21st century.

### **REUNION 2020:** VIRTUALLY A SUCCESS

Due to the COVID-19 pandemic, Cornell cancelled in-person Reunion, and instead turned to virtual events. NY Alpha followed suit and hosted a virtual Reunion on Saturday, June 6, 2020, via Zoom, since many people were already experienced with teleconferencing due to the quarantine.

The year-end total for the Development Fund in June 2020 was \$41,000, off significantly from 2019 when generous alumni contributed nearly \$78,000. ## **CHAPTER ADVISING – CALL TO ACTION**

One of the critical tenets of New York Alpha's application to Cornell University for reinstatement this fall is our chapter advising model, which provides an interactive link between our eventual active chapter and a dynamic advisory board intended to assist the active brotherhood with governance and policy issues as the chapter grows. Each advisor will serve a two-year term, and pair with a specific officer in the active chapter to develop a strong relationship and rapport. He will assist that officer with the discharge of his duties relative to the chapter, development of a strategic plan for his office, and to support the officer in general decision-making and problem-solving through the officer's term. The overall advisory board will work together with the active chapter to help the actives achieve their long-term goals and ensure compliance with key Cornell and SAE National policies that are critical for our long-term success.

We have been fortunate to have keen interest both from our own New York Alpha alumni, as well as other SAE alums, Cornell faculty, and Cornell staff in joining this advisory board, but we still have several openings that may be a great fit for you! Perhaps you have a special ability to connect with undergraduate-aged students, a strong financial background that might be helpful for a treasurer to lean on, great leadership skills that an eminent archon could take advantage of, food service experience that the steward might be able to draw from, marketing and communication experience that the eminent chronicler may use, risk management expertise for the EDA/risk manager ... I could go on and on. There's a place for each of us!

While being near Ithaca to potentially support some face-to-face interactions would be great, this is not a prerequisite for all roles, since we are all well-equipped with tools for effective remote communications these days. One advisor will serve as a live-in advisor, having residence at Hillcrest and interacting on a daily basis with the members of the active chapter; the balance of the advisory board will be asked to meet on a biweekly basis with their paired chapter leader, as well as to participate in a monthly advisory board meeting.

We plan to elect the initial advisory board in advance of the election of the first group of undergraduate leaders for the new chapter, once approved by the university. This will allow the advisory board to begin work immediately with the chapter leaders, as they take on their very important role associated with the chapter's return to Cornell.

I know from my personal discussions with a lot of you that many of you want to know "what you can do to help?" This advisory board is a great opportunity to jump in and offer your expertise for the longterm good of the chapter.

complete. The trim has been addressed as have the walls and ceilings in all these rooms. The beams in all the rooms have also been refurbished. It is the first time in more than 15 years these areas have been enhanced, and the first time in many more years that all these rooms have matched one another.

The paneling all the way up the stairs, the stairs themselves, and the banisters will all be refinished during the balance of this year or early in 2021.

The finishing touch will be decorative new wrought iron grills forged into attractive designs for the three fireplaces. The fireplaces will remain unusable because of fire safety considerations.

When all of that is completed, we can go back to working on the rec. room in the basement, which was put on hold a while back. That is a big project, as you know, and we hope that it is on our horizon to do.

So thanks to all of you who have contributed to the Hillcrest Development Fund over the years. We hope you get a chance to enjoy the results!
